Mission of the Northside High School Museum

The Northside High School Museum is a non-profit organization that is registered with the Internal Revenue Service under Section 501 © 3 under the Internal Revenue Code. Its purpose is to locate, gather and display all available materials and memorabilia related to the history of the early education of Blacks in Pittsylvania County from 1903 through 1969. It will be used to inform and educate the community and others relative to the history of education of our Black ancestors. The museum will highlight the early educational contributions of the teachers, staff, students and all of our Black citizens of that time period in a manner which will be beneficial to all who are exposed to these contributions. " We are preserving our own history as we know it."

Objectives of the Northside High School Museum Committee

1. To gather all historical educational information pertinent to the education of the Black Citizenry of Pittsylvania during the era of 1903 through 1969.
2. To interview all available teachers/ instructors and staff that contributed toward the education of our Black Citizens during that time period.
3. To provide our current citizens and all interested individuals information regarding the achievements and accomplishments of the early Blacks in Pittsylvania County.
4. To build a permanent place to preserve and display artifacts and memorabilia relative to the Black High School that existed in Pittsylvania County from 1903 through 1969.
5. To develop strategies and ways to use this museum as a bridge showing how important early Black education was toward the success and achievements of Blacks of today.
6. To show how important early Black education was toward the development of the whole Black community (economically, spiritually, politically and socially).
7. To have a showcase to display the achievements and show the end product of what the early education of Blacks meant to our society.
8. To collect and display all memorabilia available pertaining to all individuals of the early Pittsylvania County Black Educational System.

Dear Applicant:

I extend congratulations on behalf of the Dr. Martin Luther King, Jr. Memorial Commission on the dedication of the Northside High School Museum, and I commend the Northside High School Museum Committee on its interest, diligence, sacrifice, and perseverance to preserve the memorabilia, artifacts, and remnant of the formerly all-Black Northside High School in Pittsylvania County.

As you are aware, growing out of the 50th Anniversary of *Brown v. Board of Education*, the MLK Commission has as one of its objectives the identification and preservation of formerly all-Black public schools in Virginia. The Commission has undertaken such a daring project in order to preserve and protect the history of African Americans in the Commonwealth so that this generation and those to come may come to understand and learn to appreciate the difficult struggles and immense sacrifices upon which their success rests. The Museum Committee's relentless effort to ensure that the role and contributions of African Americans in Pittsylvania County are recognized and that a frequently neglected part of Virginia's history is exposed through the creation of the Northside High School Museum demonstrates the determination and fortitude of descendants of an enslaved people to prevail against all odds.

The dedication of the Museum comes at a pivotal time in the history of the Commonwealth, in which we commemorate the 55th anniversary of the landmark *Brown* decision, the 50th anniversary of Massive Resistance, and the 47th anniversary of Dr. King's historic "I Have a Dream" speech at the base of the Lincoln Memorial. Although, by the grace of a sovereign God, we have traveled far on this journey of human dignity and equal justice, we must always remember to set our eyes on the prize because there are yet many miles to travel before we will have the luxury of resting. We must inculcate the rich history of African Americans in our children and we must "*demand*" that they fully exercise their gifts and honor the sacred legacy that is their inheritance, by excelling in every endeavor that their hearts and hands pursue.

We have considered it a great opportunity to work with the Northside High School Museum Committee over the past three years on this significant enterprise, the Northside High School Museum. We are confident that the Museum will be a beacon in the community to enlighten citizens about Virginia's history and the achievements and contributions of African Americans, and an inspiration to future generations of Virginians.

I am writing to you today to offer my full support of Northside High School Museum's grant application. Northside High School was a school educating black children in Pittsylvania County from 1903 through 1969.

When I was a member of the House of Delegates, I had the honor of serving on this important Commission. In 2007, Northside High School Museum Committee approached me to support this project, which I did before this Commission, and they received a grant of \$7500 to begin the first phase of the museum. Since that time, a local church donated the space in the basement for the museum. The Committee has been working tirelessly over the last two years in the renovating of this space and providing a separate entrance for the museum. They plan to complete this project by June 2010 so they can hold a Labor Day event which would be open to the public.

Northside High School Museum is a great project to educate and inform the community about the history of education of our ancestors. It will highlight the contributions of the staff, students and the black community, and display memorabilia which has been preserved and collected over the years by many people.



Northside Marker

From 1903 through 1969 when the county schools were segregated, the school name was changed several times before being named Northside High School.

- 1903 – 1906 Pittsylvania Industrial Academy
- 1906 – 1933 Pittsylvania Normal Collegiate Institute, Inc.
- 1933 – 1948 Pittsylvania County Training School
- 1948 – 1969 Northside High School



Rev. Dr. G. W. Goode
Principal 1903 – 1933

In March of 1903 the school Pittsylvania Industrial Academy was organized. This was the first school for Blacks to receive their education beyond the elementary level in Pittsylvania County. In 1906 the name Pittsylvania Industrial Academy was changed to Pittsylvania Normal and Collegiate Institute, Inc. Rev. Dr. G.

W. Goode was the founder and the backbone of this organization and he served as its leader from 1903 through 1933.



Professor Richard Jones
Principal 1933 -1948

The name Pittsylvania Normal and Collegiate Institute, Inc. was changed to Pittsylvania County Training School in 1936 and it was made a public school. Prof. Richard J. Jones served as president and principal from 1933 to 1948.



Mr. Albert Tippitt **Principal 1948 – 1968**

The name Pittsylvania County Training School was changed to Northside High School in 1949. Albert Tippitt served as principal of Pittsylvania County Training School and Northside High School from 1948 through May, 1968. Tippitt was principal for 20 years before accepting a position as an educational specialist with the U.S. Department of Health, Education and Welfare.



Mr. James H. Harris
Principal 1968 – 1969

James H. Harris served as the last principal of Northside High School, beginning the summer of 1968 and remaining principal up until the total integration of Pittsylvania County Schools in the fall of 1969. Upon integration of schools, the name Northside High School ceased to exist except on the record books of history and in the hearts and minds of Alumni and the Black citizens of Pittsylvania County.


**Joan Tarpley Robinson portraying Harriet Tubman



Richard J. Jones – First graduate of Pittsylvania Industrial Academy - 1907 (School name later changed to Northside High)




Richard J. Jones' Diploma – Graduated in May 1907


Early Black Elementary Schools in Pittsylvania County.

These one and two room elementary schools were feeder schools to Northside High School. From the beginning when elementary schools were established in the county there were between eighty and ninety elementary schools in the county. There was no electricity, no water, and no bathrooms in these schools. The schools were heated by coal and/or wood and the students either brought their water from home or they went to a nearby spring.








