# Update on Library of Virginia Black Delegate Book Project: 'To Secure Justice for Ourselves': Black Virginians Claim Their Freedom

The Library of Virginia is publishing a book with University of Virginia Press based on biographies of Virginia's 92 Black legislators who served in the nineteenth century. The book derives in large part from research that began in 2012 with the Commission's African American Legislators in Virginia project, which the Commission completed in partnership with The Library of Virginia. The Commission agreed at its May 15, 2023, meeting to partner with The Library of Virginia on the book project and fund up to \$2,500 of the project's costs. Dr. Kimball updated Commission members on the status of the book, which is expected to be released in June. An event will be held in June when the book is released.

# The Reverend Dr. Curtis West Harris Monument Project

At its May 15, 2023, meeting, the Commission voted to purchase a \$5,000 bust of the Reverend Dr. Curtis West Harris to support the plans of the Martin Luther King, Jr. Memorial Foundation, Inc., (the Foundation) to place a monument to Reverend Harris in Hopewell. The monument, which features a bronze bust of Rev. Harris atop an African black granite pedestal, will be unveiled in Hopewell on December 2, 2023. Herbert Bragg, chairman of the Foundation, extended an invitation to members of the Commission to attend the unveiling.

# History of Lynching in Virginia

The History of Lynching in Virginia work group was created in 2018 to develop programming to bring awareness and recognition of the history of lynching in Virginia. The work group put forth HJ 655 (McQuinn) and SJ 297 (McClellan) in the 2019 Session of the General Assembly to acknowledge with profound regret the existence and acceptance of lynching in the Commonwealth; the resolutions passed both houses unanimously. The work group was not active for much of the COVID-19 pandemic, but the Commission determined that it will reconstitute the work group and resume its work immediately following the 2024 Session of the General Assembly.

#### **Tribute to Senator Yvonne B. Miller**

#### Senator Mamie E. Locke, Vice-Chair

Senator Locke spoke about the life and legacy of Senator Yvonne B. Miller, and the Commission discussed plans for a memorial tribute to Senator Miller to be placed in Capitol Square. The Commission received a \$50,000 budget appropriation in fiscal year 2022 to begin the process of planning the memorial. The Commission is establishing a work group to determine how the project will go forward. Members also discussed introducing a resolution in the 2024 Session to honor the 40th anniversary of Senator Miller's election to the General Assembly.

# Virginia Union University Community Leaders Breakfast


#### Delegate McQuinn, Chair
